Note: APPLICATION FORMS WILL NOT BE ACCEPTED UNDER ANY CIRCUMSTANCES AFTER 29-06-2018. For late submission of application forms, a penalty of Rs. 2,000/- per day will be charged against the colleges. The detailed Time-Table will be notified in due course.

Instructions to the Candidates:

- 1) The Candidates have to submit a xerox copy of the Memo of Marks of their qualifying examination, along with application forms.
- 2) The Candidates should confirm their eligibility as per the norms before remittance of examination fee. It may be noted "Fee once remitted will not be refunded or adjusted under any circumstances."
- 3) Late fee of Rs.1,000/- will be imposed for according late permission to the Candidates after the due date. However, no application will be entertained after the commencement of examinations.
- 4) The appearance in the examinations by the candidates will be subject to eligibility and promotion norms. They will forego the results of the Exams appeared in deviation of norms.

The Principals of the colleges concerned are requested to adhere to the following:

- 1) Ascertain the eligibility of the Candidates before sending NRs. Forward the applications of eligible candidates only. If any deviation found, College concerned will be penalized @ Rs. 20,000/- per each deviation as per the academic regulations.
- 2) The demand draft(s) shall be drawn in favour of the "Registrar, KU Examinations Account" payable at the State Bank of India, K.U. Branch (Code No.020262), Warangal.
- 3) Submit the following along with the Nominal Rolls of the Candidates:
 - a) Application Forms
 - b) No Dues certificate from the Dean College Development Council and Academic Audit for every exam and from Academic Section for the I Year or I Semester Exams of Any course, KU
 - c) Required fee in D.Ds.
 - d) 3 Sets of NRs with a soft copy & paper wise statistics in the prescribed format
 - e) Names of the Candidate and his/her Father should be as printed in the qualifying examination/Degree.
 - f) Internal/Sessional Marks should be uploaded online through kuonline.com and submit the hard copies at the Examination Branch before commencement of Examinations.
 - g) Practical examination schedule (in batches), along with the nominal rolls should be submitted in time without fail.
